The results of the study show that the framing that has been carried out by TvOneNews is to be able to form a point of view of what is reported that will be broadcast to the public in the case of reporting on the Ferdy Sambo case. candrawathi is a defendant in this case. The way TvOneNews reconstructs news is by checking facts and verifying the sources used.

There is a difference reported by TvOneNews.com and JawaPos.com, namely the obligation to enforce the law as fairly as possible and TvOneNews.com reported that they were concerned about the condition of Candrawati's daughter. (Hasbiansyah, 2023) stated that in and Detik had reporting Kompas differences in reporting on Putri Candrawathi. Kompas framed Putri experiencing sexual Candrawathi as violence in the form of rape while Detik also had the same discussion regarding sexual violence in the form of rape but this could be said

to be irrelevant to the main case, namely, the murder done by ferdy sambo. (Purba, 2022)

The results of this study stated that the total

broadcast time, duration, and the number of views related to the Ferdy Sambo case in August 2022 can be said that Kompas YouTube media can influence what the audience thinks about, and with this broadcast can attract public attention, and what is considered important in the media is also considered important by society. The differences between the above research and this research are as follows:

This research focuses on how to see the perspective of a journalist in publishing a news item on TvOneNews regarding the news of the Ferdy Sambo murder case and how to find out a motive in the framing analysis conducted by TvOneNews. The motive of the framing analysis is carried out to find out what purpose a journalist conveys in the news, not only by considering the difference in information from other media. The following is the basic theory that researchers use as the basis for this research, namely:

1) (Pan & Kosicki, 1993) in their writing "Framing Analysis an Approach to News Discourse" divides into 4 structural dimensions of the news text as a framing device, namely syntax, script, thematic, and rhetorical. This model assumes that every piece of news has a frame that functions as the center of the organization of ideas. Frames are related to meaning. How one interprets an event can be seen from the set of signs that appear in the text

2). The theory used in Eriyanto 's book entitled Framing Analysis; Construction, Ideology, and Politics (2002), provides 4 stages in analyzing media framing as follows: Define problem, Diagnose causes, Make moral judgment, Treatment recommendation.

The reasons for choosing framing analysis are as follows: to be able to analyze an issue and news by seeing how the perspective or point of view used by a journalist or mass media in a news story and how to select issues and write a story, with framing analysis we can see a reality

Furthermore, the reasons for choosing TvOneNews are as follows: TvOneNews has existed since 2008 and focuses on news content, especially on political news in Indonesia with a composition of 70% of the news displayed, according to a report issued by the Reuters Institute for the Study of Journalism and the University of Oxford in 2021 said that TvOneNews is the most trusted media by the public with a trust score of 53%. What makes researchers believe and want to make this the object of this research is because of the high level of public trust in this issue, especially since TvOneNews is very factual and accurate in its existing news.

Based on the explanation above, this study determines the formulation of the problem as follows :

1. How is the analysis of framing in the online media TvOneNews?

2. How does TvOneNews reconstruct a story?



This data will be used as an explanation of how the agenda setting carried out by TvOneNews attracts the attention of many viewers to make this topic important.

The focus of this study is on one case that has been in the public spotlight since July 2022. To develop a detailed analysis of the death of Brigadier General Nofriansyah Yosua Hutabarat. Research instruments that researchers do by way of data collection methods used are observation, documentation, and archival research. The method of data analysis is descriptive analysis, thematic analysis, and affirmation. in searching for data researchers used the exact method used by researchers Pan and Kosicki (1993), in their paper Framing Analysis an Approach to News Discourse, dividing news texts

into four structural dimensions as a means of framing: syntax, descriptive, topical, and rhetorical. Syntactic structure How the news is structured in units under consideration: headlines. notes. background information. references. statements, and conclusions. The script structure allows message integrity to be observed at 5W+1H. Subject structure How journalists express their views on events in sentences, phrases, or the relationships between sentences that make up the whole text. Rhetorical structure journalists How emphasize certain meanings in news. This model assumes that each message has a framework that acts as a central place for organizing ideas. Frames are associated with meaning. How to interpret the event can be read from the series of letters that appear in the sentence. Data Collection Techniques In this study, researchers can display the names of reporters, authors. editors. and involvement of editors, so that the data is expected to be more valid. For this study, researchers looked at three news articles published on the TvOneNews YouTube channel. This figure was determined by the researcher because it was considered sufficient to represent how the framing was done, data obtained from various sources to refine the researcher's ideas.

Frame: The statement of the legal advisor team that doesn't make sense

**Syntax:** It makes no sense to prove the element of intent without looking at the motive. This is a very sensitive statement in response to this trial. which is the answer from the legal advisory team of Ferdy Sambo and Putri Candrawathi. This background is very controversial because according to him the motive is not part of the core. What is highlighted in this news is the statement issued by the advisory team which is considered to be an important matter to prove intentionality.

**Script:** The statement from the team of legal advisors in this trial was considered very controversial because they considered that the motive was not a standard offense. this is considered an irrelevant statement in this case.

**Thematic:** This news has been proven true through statements from the legal advisors during the trial. this statement disclosed is considered necessary to be questioned because it considers that the motive is not a standard offense, that motive is not part of this.

**Script:** The element that is highlighted in this news is how Ferdy Sambo removed the DNA from the weapon used and the strategy used, the thing that is hidden is that there was the fact that Ferdy Sambo was manipulating on behalf of Joshua who shot him at the wall, and the name of the weapon that was never found out by the public. **Thematic:** In this case, the news can be said to be valid because the results of the trial are true, this news is in more detail on the side of Ferdy Sambo who was the defendant at that time, with the examination that was carried out there were also many facts that Ferdy Sambo revealed which made this case open.

**Rhetorical:** The point highlighted in this report is how Ferdy Sambo lost the evidence on the weapon used in the premeditated murder of Brigadier Joshua and manipulated the weapon used.
